1. 5 years of construction industry safety experience **OR**
2. 3 years if he/she holds a Certified Safety Professional designation from the Board of Certified Safety Professionals. **OR**
3. safety and health degree

Attendees must attend all classes. Upon completion of the course and passing 80% of the test, the **NAVFAC Construction Safety Hazard Awareness Training for Contractors certification and OSHA 30 Hour card** will be given.

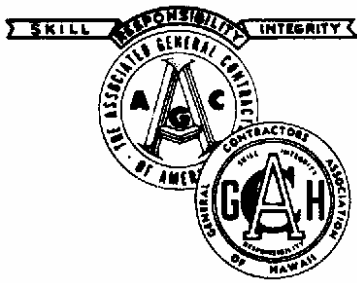
